Please find enclosed January to June 2021 schedule for the Texas Driving While Intoxicated Education Program (DWI) classes for your region. This schedule is for the first 6 months of 2021 due to the uncertainty of the CoVid-19 Pandemic. The schedule for July to December 2021 will be sent to you in June. ADAC will continue to adhere to the safety guidelines mandated by the Office of the Governor and Texas Department of State Health Services. As you may know, having in person classes allows participants to connect with the Instructor, be more successful in learning and retaining important information and help identify potential current problems related to alcohol and/or drug use. The following is a list of important information for the participants to know when needing to take the DOEP class:

- Participants must call ADAC's main number (936) 634-5753 to get on the list as there will be a limit to how many will be in a class due to the size of the rooms and current safety guidelines regarding the CoVid-19 Pandemic.
- Fee is \$80.00 (money order or cashier check).
- Each participant must know their cause number and county of conviction at time of class.
- Participants must attend all three scheduled days of class in consecutive order to successfully complete the program.
- All classes are held Monday-Friday, three hours each night.
- DWI NIGHT classes will be held on **Tuesday, Wednesday, and Thursday** nights
- DWI DAY classes will be held on **Saturday, Sunday**, and the following **Saturday**

Thank you for your continued support in our ability to offer these classes in the locations/times that we have and to individuals who are needing to comply with court orders and/or get their driver's license out of suspension due to their offense and conviction.
